<b>3.0</b>	<b>POLICE REPORT</b>	
3.1	<p><b>Community Police</b> – Officer Ross Blain attended and noted various crime reports since the last meeting. 22 crimes were reported in the S Kirkintilloch/N. Lenzie area, 11 of these being detected. These included road traffic offences, assaults and Breach of Peace. Nine crimes were reported in the S Lenzie area, 5 of these being detected – including road traffic offences, a drug case and 2 assault/BoP.</p> <p>There was discussion concerning instances of anti-social behaviour and also confirmation that more effective support would be given in future in relation to the Christmas Lights event. Officer Blain was thanked for his attendance and contribution.</p>

<b>5.0</b>	<b>MATTERS ARISING</b>	
5.1	<b>Bus routes</b> – There had been further correspondence with Mr Tait, who had accepted that there was little to be gained by contacting Firstbus further at this stage and who would supply any further information to Cllr Geekie.	
5.2	<p><b>War memorials</b> – Donald MacLeod had visited Alice Mackenzie, who had made the suggestion for a central war memorial and clarified some aspects. There are three memorials inside Lenzie Churches, one in the open air at Woodilee and others in the Public Hall and in Lenzie Academy. Her suggestion is that there should be a small plaque or similar, placed in the vicinity of the Station, which directed any interested visitors to a book that would contain all the names of those memorialised and the locations of their respective memorials. She could give assistance with compilation of the book and members noted that the information could be added to the Community Council website. The suggestion for a plaque would perhaps be more difficult to follow up, in relation to cost and negotiation with Network Rail. However, it was noted that the team responsible for the Lenzie Street Design project were already considering the re-location of the Community Council noticeboard and a location for a War Memorial plaque might be added to that requirement.</p>	<b>TG</b>

A member asked for an explanation concerning the fact that the Planning Case Officer had recommended that the application should be refused. Cllr Geekie noted that the Report had appeared contradictory to Councillors and there was no opposition to the motion to grant approval.
