3.0 POLICE REPORT

Constables Jennifer Murray and Ian Marshall attended and reported crime statistics for the period since the last meeting. There was no major rise in crime. Car crime had been a major focus, including absence of tax discs, MOT certificates and theft of and from vehicles. Anti-speeding campaigns had been mounted on the Link Road, Boghead Road and other locations. Various comments were made by more than one member on inadequate sight-lines at the Townhead roundabout where vehicles entering the roundabout from the south are faced with traffic appearing at excessive speed from the right. Similar concerns were raised about the roundabout at the exit slip (north) from the M80. Otherwise, incidents were mainly of an anti-social nature, including vandalism.

5) It was noted that current funds total around £ 3,000, excluding above grant money

Rosemary Craig had purchased gifts for the Gala Queen and her attendants and a cheque for £74 was provided to Rosemary.

8.0 PLANNING

8.1 The Planning Convener had circulated a summary of the various Planning Applications since the last meeting. The meeting agreed with his assessment that none of these applications were contentious from the Community Council point of view.

8.2 There was discussion of an application in respect of a vacant site on Heath Avenue. It was not clear how this proposal related to the adjacent house in terms of access, but the plan appeared to be at the outline stage.
